General Information

1. Games will consist of two (2) twenty-five minutes halves.
2. The regular season standings will seed teams into the championship tournament.
3. Trophies will not be awarded after the regular season. Individual trophies will be awarded to the first and second place teams in the championship tournament.
4. Goalkeeper shirts and soccer balls will be collected immediately after the last game of the tournament.
5. In the event of inclement weather, games will be played or canceled on a game-by-game basis at the soccer fields as late as game time. The Troup County Parks & Recreation Information line (706/298-8888) may be called for the latest information, but the variability of the weather and playing conditions usually make it necessary for players to come to the playing field to see if games are being played or canceled.
6. Field A is the 1st field on your left as you turn into the driveway of the soccer complex. A-1 is beside concessions
7. Winter registration will be October 22nd - November 2nd.
