General Information:

3. If teams are tied for first place with identical records, the team winning in head-to-head meetings during the regular season will be declared the champion. If there is still a tie between two teams, a single elimination playoff will be played. If there is still a tie between three teams, coaches will draw out of a hat to determine the playoff games. One team will receive a bye and play the winner of the first playoff game for the championship.
4. The first place team will be awarded individual trophies.
5. Coaches, please remember to clean the dugouts when your game is complete.
